Interpreter's report: 2018 Dave Christiansen and Carleton Laird, Co-Interpreters

- -Intentional walk...same as baseball: Ball is dead
- -Playcard/wristband is equipment, worn on non-throwing arm, single color
- -No longer need to inspect equipment, confirm at plate meeting. If it happens during the game, a player/coach needs to approach umpire to ask them to check it. Same penalty, batter out, warning to team
- -Charged conferences 3-7-1, pitcher removed, umpire not required to give warmups
- -Clarification on 6-1-2b Pitcher step back...step back may end before or after hands come together
- -6-2-5: Reminder, a minute between innings. If teams insist on meeting at beginning of each half-inning, let coach know pitcher may not get warm-up pitches
- -Hit by pitch: Batter not required to move if pitch is in batter's box, but must make an effort to move all balls not in the batter's box. No base will be awarded unless batter attempts to move or ball 4
- -8-1-2 Batter's hands are not part of the bat
